

VETOQUINOL STRENGTHENS ITS PRESENCE IN CANADA IN THE COMPANION ANIMAL MARKET

Lure, France – July 1, 2008 – Vétoquinol announces the acquisition of the animal health business assets of VETCOM 1979 INC.

The animal health business of VETCOM 1979 INC. includes annual revenue of around CAD1.5 million. The company covers nearly 65% of the market for ophthalmological unguents in Canada.

The assets transferred in the deal are a portfolio of ophthalmological products, some non-sterile products that will be manufactured by the production unit of Vétoquinol located in Princeville, Canada. The products that were sold include the market clearances related to them.

Number three in Canada, Vétoquinol is today firmly established in the livestock market, which accounts for the majority of its revenue. This acquisition in the companion animal segment contributes to building the group's strategy of maintaining a balance between species.

"These anti-infectious ophthalmological products, which are top-of-market and technical, are a very good fit with our current range. They will be added to the portfolio of our dedicated companion animal sales force in Canada," said Etienne FRECHIN, Chairman and CEO of the Vétoquinol group.
